RESIDENTIAL PROGRAMS INCLUDE A 40 BED EMERGENCY HOUSING PROGRAM, 12 UNITS OF SCATTERED SITE TRANSITIONAL HOUSING FOR FAMILIES, AND 50 UNITS OF PERMANENT SUPPORTIVE HOUSING FOR FORMERLY CHRONICALLY HOMELESS ADULTS.

DURING FISCAL YEAR 2012-13, THE ASCENCIA ACCESS CENTER SERVED 1160 HOMELESS MEN, WOMEN AND CHILDREN. OF THOSE 256 WERE SERVED BY STREET OUTREACH. 631(54%) REPORTED AT LEAST ONE DISABILITY. 83(7%) WERE VETERANS, 65(6%) WERE SENIORS AND 290(25%) WERE CHILDREN. IN ADDITION TO PROVIDING SERVICES TO THE EMERGENCY HOUSING PROGRAM, THE ACCESS
